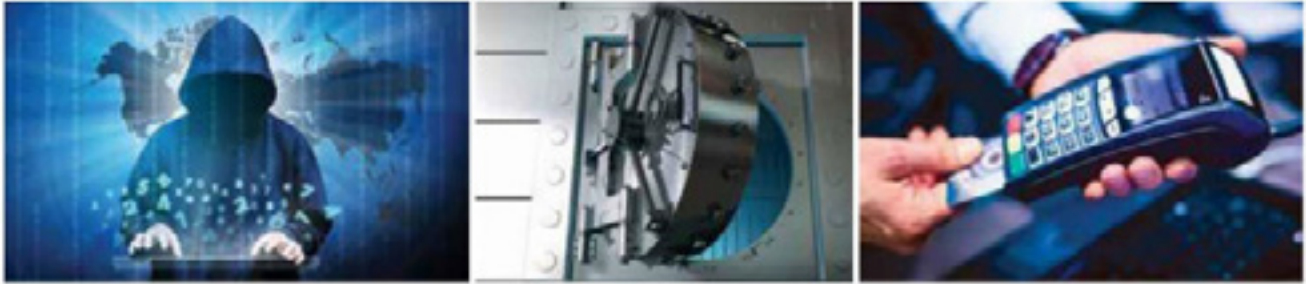

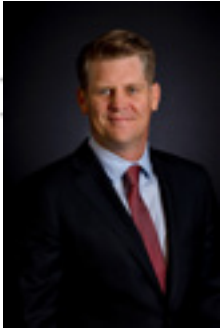

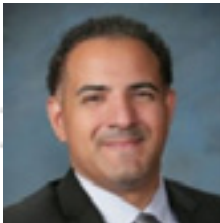

Economic Outlook: the Expansion Continues, But for How long?

The national economy appears on track for continued expansion but at a slower pace, while Arizona once again is a leader in job growth and population gains. But how long will the party last? She has years of experience shaping and managing state budgets and helped create Arizona's booming economy by working to keep taxes low and eliminate unnecessary regulations. 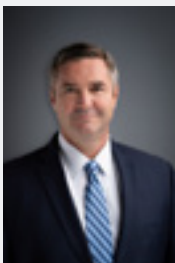

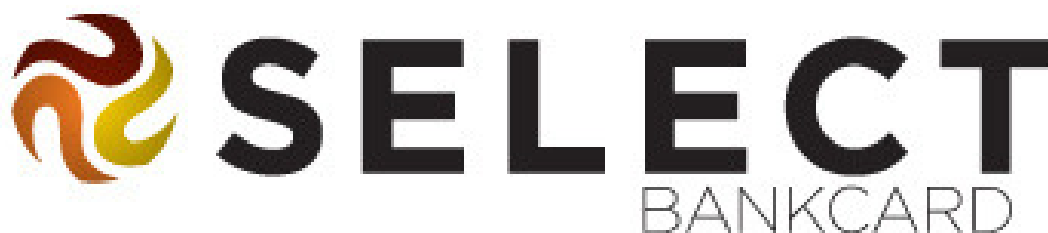
